

Privacy Policy

ITT Inc. Privacy Policy for App Users

By downloading our mobile application ("App"), you agree to our collection, storage, and use of your information as described in this Privacy Policy.

ITT Inc. and our affiliates and subsidiaries ("ITT") know that you care about how your information is used and shared, and we take your privacy seriously. This Privacy Policy explains our information practices with regard to the App, the kinds of information we may collect, how we intend to use and share that information, and how you can opt out of a use or correct or change such information.

ITT complies with the requirements of the EU-U.S. Privacy Shield Framework and the Swiss-U.S. Privacy Shield Framework (collectively "Privacy Shield"), as set forth by the U.S. Department of Commerce and the Federal Trade Commission ("FTC"), regarding the collection, use, and retention of Personal Information transferred from the European Economic Area and Switzerland to the United States. ITT has certified to the Department of Commerce that it adheres to the Privacy Shield Principles and Supplemental Principles. If there is any conflict between the terms in this Policy and the Privacy Shield Principles, the Privacy Shield Principles shall govern. Additionally, ITT may protect information through other legally valid methods, including international data transfer agreements.

How of ITT Collects Information

Some of the ways ITT collects personal information through the App include:

- You may provide information directly to ITT, such as when you download and use the App.
- As you use the App, certain passive information may be collected about your use of the App.

We endeavor to only collect the information which is relevant for the purposes of providing the App.

Types of Information ITT Collects

• Information You Provide Directly to ITT. When you use the App, ITT may ask you to

provide some or all of the following types of information:

- **Personal Information.** ITT does not ask for personal information. If ITT did have access to personal information, ITT would use this personal information consistent with ITT's Global Privacy Policy.
- Machine Data Information. ITT does not collect machine data information. If ITT did have access to machine data information, ITT would use this machine data information consistent with ITT's Global Privacy Policy.
- Information We Collect Through Your Use of the App. When you download and use the App, ITT currently has NO plans to collect usage data. If ITT did have access to Usage Data, ITT would use this machine data information consistent with ITT's Global Privacy Policy

How ITT Uses the Information It Collects

• ITT does not plan to collect data as indicated above.

Disclosure of Data

We are not in the business of selling or renting user data. We will not share data with third parties outside of ITT except in the following circumstances:

- We contract with vendors, consultants and other service providers to provide services for us (such as customer support, email marketing, and technical infrastructure services). We may provide these companies with access to data where necessary for their engagement. With respect to onward transfers to agents under Privacy Shield, Privacy Shield requires that ITT remain liable should its agents process personal information in a manner inconsistent with the Privacy Shield Principles.
- If we believe in good faith that we must disclose information pursuant to a court order or subpoena to protect the rights or property of our company or other users, including to prevent fraud or to enforce our agreements or policies governing your use of the Service; or if we believe in good faith that such disclosure is necessary to protect the personal safety of our personnel, users, or the public, we may make such disclosure as we believe is reasonably necessary for such protection.
- If we sell or reorganize all or part of our business, we may need to disclose user information to a third party who acquires our assets, as permitted by law.
- If you direct or authorize the disclosure.

International Transfers of Personal Information

You agree that all information, including personal information, collected or transmitted to ITT may be transferred, processed, and stored anywhere in the world, including but not limited to, the United States, the European Union, in the cloud, on our servers, on the servers of our affiliates or the servers of our service providers.

Opt-Out (Right to Object to Processing)

You have the right to object to and opt out of certain uses and disclosures of your personal information. Where you have consented to ITT's use of your personal information, you may withdraw your consent at any time and opt out of certain uses by contacting privacy@itt.com. Even if you opt out, we may still collect and use information regarding your activities on our App.

Rights of Access, Rectification, Erasure, and Restriction

You may inquire as to whether ITT is processing personal information about you, request access to personal information, and ask that we correct, amend or delete your personal information where it is inaccurate or has been processed in violation of the Privacy Shield Principles. Where otherwise permitted by applicable law, you may send an e-mail to privacy@itt.com or use any of the methods set out in this Privacy Policy to request access to, receive (port), seek rectification, or request erasure of Personal Information held about you by ITT. Please include your full name, email address associated with your account, and a detailed description of your data request. Such requests will be processed in line with local laws.

Although ITT makes good faith efforts to provide individuals with access to their personal information, there may be circumstances in which ITT is unable to provide access, including but not limited to: where the information contains legal privilege, would compromise others' privacy or other legitimate rights, where the burden or expense of providing access would be disproportionate to the risks to the individual's privacy in the case in question, where the request is manifestly unfounded or excessive or where it is commercially proprietary. To protect your privacy, ITT will take commercially reasonable steps to verify your identity before granting access to or making any changes to your personal information.

Retention

ITT retains the personal information we receive as described in this Privacy Policy for as long as you use our App or as necessary to fulfill the purpose(s) for which it was collected, provide our services, resolve disputes, establish legal defenses, conduct audits, pursue legitimate business purposes, enforce our agreements, and comply with applicable laws.

Information Security

ITT take steps to ensure that your information is treated securely and in accordance with this Privacy Policy. Unfortunately, the Internet cannot be guaranteed to be 100% secure, and we cannot ensure or warrant the security of any information you provide to us. We do not accept liability for unintentional disclosure.

Our Companywide Commitment to Your Privacy

This Privacy Policy shall be implemented by ITT and all its operating divisions, subsidiaries and affiliates. ITT has put in place mechanisms to verify ongoing compliance with Privacy Shield Principles and this Policy. Any employee that violates these privacy principles will be subject to disciplinary procedures.

Children's Privacy

The App is not directed to children under 16 years of age, and ITT does not knowingly collect personal information from children under 16 years of age. If we learn that we have collected any personal information from children under 16 years old, we will promptly take steps to delete such information.

Redress/Compliance and Accountability

If you have any questions about our privacy practices, this Privacy Policy or how to lodge a complaint with the appropriate authority, please contact us at privacy@itt.com. We will attempt to address your concerns and resolve any privacy issues in a timely manner.

If you are an EU or Swiss citizen and feel that ITT is not abiding by the terms of this Policy, or is not in compliance with the Privacy Shield Principles, please contact ITT at the contact information provided above.

In addition, ITT has agreed to refer unresolved complaints related to personal information to JAMS Privacy Shield Dispute Resolution Program and, with respect to employee and human resources data, has committed to cooperate with the panel established by local data protection authorities and comply with the advice given by the panel for EU citizens and with the Swiss Federal Data Protection and Information Commissioner's authority and advice for such data of Swiss citizens. Such independent dispute resolution mechanisms are available to citizens free of charge. If any request remains unresolved, you may contact the national data protection authority for your EU Member State.

You may also have a right, under certain conditions, to invoke binding arbitration under Privacy Shield; for additional information, see https://www.privacyshield.gov/article?id=ANNEX-I-introduction. The FTC has jurisdiction over ITT's compliance with the Privacy Shield.

Conditions of Use

If you decide to use the App, any possible dispute over privacy is subject to this Privacy Policy and our Terms of Use, including limitations on damages, arbitration of disputes, and application of New York state law.

Changes to this Privacy Policy

ITT may amend this Privacy Policy from time to time. If there are material changes to this Privacy Policy, ITT will notify you by email or as otherwise required by applicable law. We will post any adjustments to the Privacy Policy to the website and the revised version will be effective immediately when it is posted. You understand and agree that you will be deemed to have accepted the updated Privacy Policy if you use the App after the updated Privacy Policy has been posted.
